The UNDERSIGNED expressly acknowledges that the participant or the above-named MINOR CONTESTANT will expose the MINOR CONTESTANT (him or her) to such hazards. The UNDERSIGNED represents that the MINOR CONESTANT is physically able to participate in the event and that the UNDERSIGNED knows of no medical condition that would otherwise subject MINOR CONTESTANT to greater risk from such participation.

Release of Sponsor: The UNDERSIGNED, being full aware that participation by the above named MINOR CONTESTANT in the Mutton Bustin' (hereafter referred to as "event") competition to be held during the Florida Gateway Pro Rodeo will expose the MINOR CONTESTANT to a substantial and serious risk of property damage and/or personal injury or death, hereby releases Columbia County Resources/ Florida Gateway and each of its subsidiaries and the employees and agents of each such entity and ALL SPONSORS, (hereafter RELEASEES), from liability, and waives the right to sue, for any and all property damage, and/or personal injuries of death, or other claims arising from the above named MINOR CONTESTANT'S participation in the Event, even if the property damage and/or personal injury or death is determined to have resulted from the negligent acts or omissions of the RELEASEES.
